SLINFOLD NEIGHBOURHOOD PLAN

Following the publication of the Submission Slinfold Neighbourhood Plan (Feb), a number of minor amendments have been brought to our attention. This has resulted in a revised version of the Submission Slinfold Neighbourhood Plan (April). To comply with the Neighbourhood Plan Regulations there is a requirement to go out for a further 6 week consultation and invite stakeholders to make representations on these updates. For ease of reference a schedule has been produced to highlight the differences between the two versions of the submission draft plan. Consultants who made comments to the previous consultation over June and July, your representations will be passed to the Examiner together with any additional comments you may wish to make on the proposed amendments as identified in the schedule. Slinfold Parish Council (as the qualifying body) has prepared a Neighbourhood Development Plan (NDP), entitled "Slinfold Neighbourhood Plan 2014-2031", for their Parish with the help of the local community. The NDP sets out a vision for the future of the Parish and planning policies which will be used to determine planning applications locally. In accordance with Regulation 16, the Slinfold Plan and associated documents will go out to consultation for 6 weeks inviting representations.
